Refunds. All registrations are non-refundable and only valid at a 2011-2012 regional location. No exceptions.

Credits. On a case-by-case basis, registered participants who wish to withdraw prior to the workshop's start date due to bodily injury may do so if authenticated with an official doctor's note. Participant will be credited the cost of the workshop to be used towards a future workshop produced by PTC PRODUCTIONS, LLC, The PULSE, minus a \$25 administrative fee. No credits will be given for any other reason.

Wristband Policy. Registrants receive only one band for the workshop. Wristbands may not be removed for the duration of the convention. Lost or removed bands require full repayment of registration fee. No refunds. No exceptions.

Observer Wristband Policy. Pre-registration is strongly suggested as observer bands may sell out. If still available, they will be sold at the door starting on Friday at early check-in, cash only. All observer bands are non-refundable and may not be transferred from one person to another. The PULSE is not responsible for lost or stolen bands. You must be accompanying a dancer to observe. Noise level and activity should be kept to a minimum out of consideration for the faculty and dancers. No cell phones, talking, videotaping or note taking. The PULSE reserves the right to remove anyone who is disrupting the workshop or not following Security directions. Please note: You do not need an observer band to enter the PULSE Performance Showcase, Q & A, or Scholarship Ceremony.

Waitlist Policy. If you are completing a waitlist registration, an amended confirmation will be sent to the email address you provided. Please note that in the event that space becomes available, your credit card will automatically be charged and you will be registered in this event.

Disclaimer. PULSE staff reserves the right to remove any person (or persons) who presents potential harm, danger or disruption to themselves or anyone around them while attending the event. Also please note, due to contractual obligations The PULSE guarantees at least four (4) of the eleven (11) headlining choreographers in each city. PULSE faculty is subject to change.

Liability Release. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, I agree to release and to hold harmless the PTC Productions, LLC event The Pulse on Tour ("PULSE"), the facility on whose premises The PULSE on Tour Workshop I am attending will occur (the "Location"), and the respective directors, officers, representatives, members, agents and employees of Pulse and the Location and their respective affiliates (hereinafter collectively "Releasees") from any and all liability, whether based on negligence, contract, tort, statute or otherwise, for any claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the Pulse workshop I am attending (the "Event"), including but not limited to any claim arising out of or connected with any illness or injury (minimal, serious, catastrophic and / or death) that I may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the Event whether or not the Event actually occurs. I further expressly agree to indemnify and hold harmless Releasees and Releasees' heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by me or by any other persons on the account of damages of any character resulting to me in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, damages, or costs Releasees may have to pay as a result of any such action, claim, or demand, including but not limited to attorneys' fees.

Medical Release. I acknowledge and agree that participation in the Event subjects me to the risk of physical illness or injury (minimal, serious, catastrophic and / or death) and that I acknowledge that I am assuming the risk of such illness or injury by participating in the Event. In the event of such illness or injury, I authorize The Pulse to obtain necessary medical treatment for me and hereby release and hold harmless Releasees in the exercise of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred by me for any illness or injury that I may sustain during the Event and while traveling to and from the site for the Event whether or not the Event actually occurs.

I am aware that this Liability Release Form releases Releasees from liability and contains an acknowledgement of my voluntary and knowing assumption of the risk of injury or illness.
